Access to and within the School building is a privilege. Ongoing and unescorted access privileges are contingent upon continued responsible behavior and compliance with School policies and procedures.

Access to and within the School building and specific areas with access restrictions is restricted to :

3. Authorized visitors and contractors, who have a legitimate, business-related reason to be inside the School;

4. Teaching and performance activities attendees who require time-limited access to specific venues within the School building.

These School IDs are programmed to work with card readers that are linked to the School's centrally managed access control system. The School ID confirms that the individual in possession of the School ID is affiliated with The Tianjin Juilliard School. When the School ID is activated, it facilitates access to the School building as well as restricted areas inside the building, provided the individual is authorized to enter those areas. New faculty/staff are issued School IDs during new faculty/staff orientation, and new students are issued IDs during new student orientation and registration.

School ID Regulations

 Currently enrolled students, current faculty, staff, authorized visitors, and vendors in good standing are issued a photo School ID and enjoy ongoing and unescorted access privileges within the building, but not necessarily to all areas within the buildings. Granting access to specific areas with access restrictions will depend on an individual's role at the School and is exclusively determined by the relevant School department.

 Physical access to and within the School building is centrally managed using School ID card readers/magnetic locks and turnstiles. There are two types of IDs issued by School: School IDs and Temporary IDs. School IDs facilitate unescorted access to and within the School

building. As the name implies, Temporary IDs are temporary and are only valid on the day they are issued. Temporary IDs are issued also to employees or individuals with active School ID status when they forget to carry their original School ID card or have lost it.

学院通过校园卡门禁读卡器/电磁锁和闸机对校园卡的物理权限进行集中管理。学院发放的授权卡片有两种:校园卡和临时卡。校园卡根据人员所属的不同类别进行发放。 顾名思义,临时卡是临时的,仅在发放当天有效,但是临时卡仅仅对具备有效校园卡 身份的人员,在其原有卡片丢失或者忘带的情况下发放。

School IDs are for the exclusive use of the individual to whom it was issued. Individuals are
never permitted to lend their School IDs to anyone, or to use their ID to facilitate access for
anyone other than the legitimate ID holder.

• All members of the Tianjin Juilliard Community must show their ID to any School official or Public Safety Officer upon request.

• All members of the Tianjin Juilliard Community should always have their ID with them while inside the School building.

• All Members of the Tianjin Juilliard Community are encouraged to display their ID while inside the School building.

School ID and Practice Rooms

Practice rooms also utilize a centralized access control system as part of the reservation process. Students and faculty who reserve a practice room must swipe their School ID at the card reader located on the door of each room in order to gain access to the room.

ID Administration

• Individuals who have forgotten or misplaced their School ID must register at the Building Entrance by security guards checking identity and request a Temporary ID with basic access from Main Reception at the lobby. A separate Temporary ID will be issued each day.

• Lost or stolen School ID should be reported immediately to the Facilities and Public Safety Department so that it will be immediately deactivated.

若校园卡遗失或被盗,应立即向公共安全办公室报告以停用。

 Replacements School ID are obtained through the Facilities and Public Safety Department. The replacement cost, including a new lanyard and card holder case, is RMB 240, which needs to be paid to School Finance and receipt of the payment must be provided to Facilities and Public Safety.

重新办理校园卡应通过设施和公共安全部门进行。重新办理校园卡的费用为人民币 240元,包括新的挂绳和校园卡套,申请人需要在学校财务处支付校园卡重新办理费 用并向设施和公共安全部门提供相应的收据。

• Individuals who have requested a Temporary ID on three separate days AND have not used their School IDs since the first request will have their School IDs permanently deactivated.

若学院校园卡的持卡人累计三天申请临时卡,但自第一次申请后一直并未使用过其校 园卡,则其校园卡将永久失效。

Any School ID that has been inactive for one year will be permanently deactivated.
 Exceptions may be allowed for an unspecified period if the ID holder's department supports this individual maintaining ongoing access privileges.

• Once a School ID has been issued it must be returned to the School at the conclusion of the contract or when access privileges are no longer required, whichever comes first.
